

Top 10 Causes of Driving Hazards in Logging Operations

Driving for work is top health and safety risk

As identified by workers, supervisors, and employers in the Ontario logging industry through a root cause analysis facilitated by the Ministry of Labour, Immigration, Training and Skills Development and Workplace Safety North.



1. Vehicles with mechanical issues and older equipment with poor maintenance



6. Inadequate forest road construction and maintenance



2. Poor safety culture limits support of safe driving programs



7. Inadequate safe operating procedures for drivers



3. Inconsistent on-the-job driver training



8. Inexperienced drivers not familiar with forest roads



4. Lack of fit-for-duty program



9. Pre-shift assessment checklist for vehicle and road conditions inconsistently completed



5. Limited standards and communication between firms and the Ministry in charge of maintaining highways



10. Poorly functioning safe driving program

Approved Logging Health and Safety Training

Forestry Common Core Mandatory Skills Training in Ontario

Ontario law requires chainsaw operators (cutters) and operators of cable skidders and mechanical harvesting equipment to receive common core classroom training on health and safety principles and practices related to the equipment they have been hired to operate.

The operators of these pieces of equipment must be registered for this training before they start work and they must complete the classroom training and associated on-site competency tests within one year of being registered.

Safe Driving on Forest Roads E-learning (Disponible en français)

This course reviews the hazards of driving company, personal, or recreational vehicles on forest roads. It covers the unique physical nature of these roads, how to drive safely on them, and how to properly prepare a vehicle and driver. Defensive driving techniques on forest roads in all seasons, andgeneral safety principles are also reviewed.

Competent Supervisor Training

Health and safety awareness training is now law for every worker and supervisor in Ontario.
